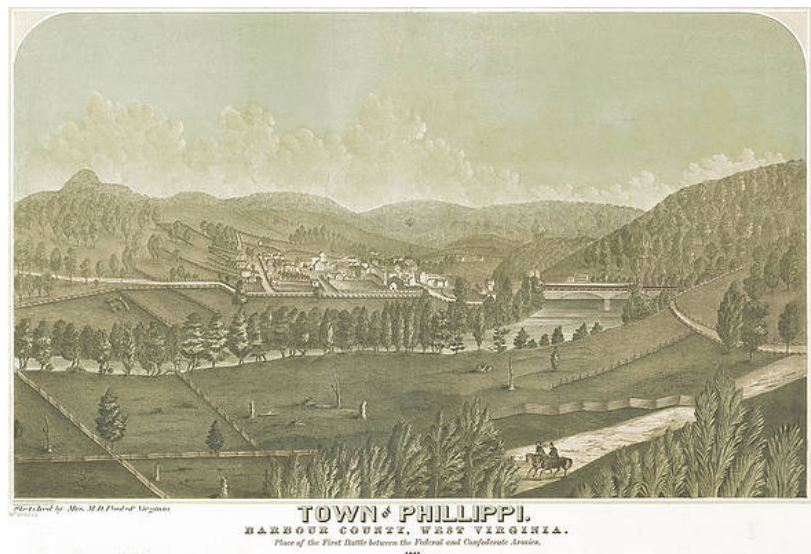

Study 2

FAITHFUL PREACHING



Background

Paul's initial time in Philippi was rather brief. Philippi was a *leading* city in Macedonia (Acts 16:12). In the short time he, Luke and Silas were there, they led a businesswoman to the Lord and baptised her (Acts 16:14-15) Paul cast out a demon from a fortune-telling slave-girl (Acts 16:16-18), disrupted business activity in the city (Acts 16:19-22), and was thrown into jail (Acts 16:23-24).

Acts 16:25 ¶ About midnight Paul and Silas were praying and singing hymns to God, and the prisoners were listening to them, Acts 16:26 and suddenly there was a great earthquake, so that the foundations of the prison were shaken. And immediately all the doors were opened, and everyone's bonds were unfastened.

Acts 16:27 When the jailer woke and saw that the prison doors were open, he drew his sword and was about to kill himself, supposing that the prisoners had escaped.

Acts 16:28 But Paul cried with a loud voice, "Do not harm yourself, for we are all here."

Acts 16:29 And the jailer called for lights and rushed in, and trembling with fear he fell down before Paul and Silas.

Paul's imprisonment had emboldened many of the believers in Rome to be confident in their preaching of the gospel. Thus, Paul had been able to multiply his preaching effectiveness by mobilising many preachers.

Each of these converts had experienced a dramatic conversion as a result of the preaching of God's Word confirmed by the Holy Spirit. After the Philippian magistrates came to Paul and Silas and apologised to them for their mistreatment, they were obliged to leave the city. It appears that Luke may have remained in Philippi to set the church in order. "The use of the 'we' in the narrative of Acts is dropped until Acts 20:5-6 when Paul returns to Philippi" (Kent et al 1996, 4). There is an ancient tradition that Luke was actually a Philippian. Upon Paul's second visit to Philippi, the Philippians warmth of affection appears to have been made clear.

Even though Paul was imprisoned he was seeking every opportunity he could to preach the gospel so that everyone could come into a relationship with the true God. To Paul, the gospel was so powerful in transforming lives (as the Philippians themselves had experienced) he was glad when God used anybody to preach it.
